

FREE TAX HELP

The Center for Economic Progress (CEP) and Ladder Up will provide free income tax preparation and electronic filing for families with annual incomes up to \$55,000 and individuals with annual incomes up to \$30,000. Volunteer tax preparers can assist in filing federal and state income tax returns for tax year 2016, and, in some cases, for prior years. Most sites will be open between January 21 and April 18, 2017. Note: The 2017 tax filing deadline is Tuesday, April 18, 2017.

El Center for Economic Progress (CEP) y Ladder Up proveerán preparación de impuestos gratis con la opción de mandar electrónicamente para familias con ingresos hasta \$55,000 e individuos con ingresos hasta \$30,000 por año. Preparadores voluntarios de impuestos ayudarán a llenar la declaración de impuestos federales y estatales para el año 2016 y, en algunos casos, años anteriores. La mayoría de sitios estarán abiertos entre el 21 de enero del 2017 y el 18 de abril del 2017. La fecha final para presentación de impuestos 2017 es el martes, 18 de abril de 2017.

- Original Social Security Card or ITIN for everyone that appears on your return
- Photo I.D.
- All 2016 tax documents (W-2, 1099 forms, etc.)
- Bank account and routing numbers
- Proof of health insurance coverage (Form 1095-A, 1095-B, 1095-C, Medicare card) or Certificate of Exemption
- Copy of your second or final property tax bill paid in 2016
- Records of college-related expenses
- Copy of your 2015 tax return
