## FOR IMMIGRANTS, REFUGEES AND ASYLUM SEEKERS

### KNOW YOUR RIGHTS

Regardless of your immigration status, the U.S. Constitution provides you with basic rights, including due process and equal protection rights. As an immigrant, refugee or asylum seeker, you have different rights to federal protection and services consistent with your immigration status in the U.S.

If you encounter an immigration or law enforcement officer, you can inform them of your rights:

- To remain silent and not answer questions.
- To contact an attorney immediately, if you are detained.
- To refuse to sign anything without advice from an attorney.

The Illinois TRUST Act (5 ILCS 805) restricts local law enforcement from collaborating with federal immigration enforcement agents to detain anyone without a judicial warrant.

Your eligibility for federal and state services, and opportunities listed above, may be determined based on your immigration status.
